Through the reference 1st cited, Empanelment of Vendor Registration for Ductile Iron Valves (2nd spell) was given for the firm M/s Super Valve Mfg. Co., 29/2/3/1, Narasingha Dutta Road, Kadamtala, Howrah - 711 101, West Bengal for a period of two (2) years for pressure ratings of PN 10 & 16, having validity i.e., upto 14.02.2019.

Now, based on the references 2<sup>nd</sup> to 4<sup>th</sup> cited, it is proposed **for renewal** of vendor approval for intra village given for the said firm for further period of **two (2)** years, and all the conditions laid down in the proceedings issued vide 1<sup>st</sup> cited holds good.

- The Manufacture of DI Valves shall be with DI of grade GGG 40/ SG400 or GGG50/ SG 500 or equivalent grade as per IS: 3896-part 2-1985 and subsequent revisions.
- 2. This registration is only for purchase of above materials for Telangana Drinking Water Supply Project and not for propagation furthering interest of marketing by publication in newspaper or advertising in any form.
- 3. The Renewal of vendor registration will be valid for a period of 2 years only from the next date of validity of previously issued proceedings (i.e., from 15.02.2019 to 14.02.2021) and after review of performance and if satisfactory only vendor registration shall be extended for further period on par with other vendors registered. However, shifting of unit or any alteration activity carried out in the unit mentioned above will attract fresh shop inspection and

periodical renewal of relevant documents shall be brought to the notice of Dept. immediately.

- 4. The performance of DI Valves shall be reviewed for every 2 years at the usage ends by the Vig & Quality control wing of RWS&S dept and after fulfilment of satisfactory performance only, the vendor registration shall be extended for further period subject to fulfilment of the renewal terms and conditions.
- 5. During the vendor registration period of approved firm, if the products offered for inspection, rejected (or) the performance of the supplied materials is not satisfactory, then the firm registration will be cancelled and further renewal will not be accepted.
- 6. This approval does not mean a guarantee for purchase of materials mentioned above. The Dept. reserves right for cancellation of firm from vendor list without assigning any reason and also reserve the right and absolute discretion to call for the documents even during the validity of registration period. The Firm shall have to apply for re-registration well in advance i.e. three months prior to the expiry date of registration/approval.
- 7. During the currency of vendor registration, the clauses stipulated in the EOI at the time of vendor registration shall prevail.
- 8. The warranty period shall be minimum as stipulated in the agreement conditions of Dept. works.
- 9. Any discrepancy noticed in this proceedings shall be brought to the notice of the under signed within 15 days.
